With reference to your application dated 26.03.2008 and subsequent correspondence with the school/inspection in this regard, I am directed to convey the grant for Provisional approval of the Competent Authority of the Board for Middle Classes syllabus for a period of three years w.e.f. 01.04.2013 to 31.03.2016.

The above sanction is subject to fulfillment of following conditions:-

- 1. "The School will follow the syllabus on the basis of curriculum prescribed by NCERT for the middle classes."
- 2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT.
- 3. The school will follow CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009 in the school.
- 4. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
- 5. The grant for approval of the middle classes is not extendable and does not in any way imply any obligation on the part of the Board to affiliate the Secondary Classes (IX-X).
  - The approval will also be subject to the condition that the school will make a fresh application for Provisional Affiliation of the Secondary Classes (IX-X) to the Board on line through CBSE website <a href="https://www.cbse.nic.in">www.cbse.nic.in</a> in accordance with the rules and condition for Provisional Affiliation when classes VIII has been started.
- 7. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under:-

- (d) School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.
- 8. The school shall appoint only qualified and eligible staff as per qualification laid down in the rules.
- 9. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
- 10. Service conditions, pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
- 11. The school and its records shall be opened for inspection by an officer/official of the Board or an authorised representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.

  12. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
